The District Department of Transportation (DDOT) will be posting Emergency No Parking Signs (ENPS) for the 2013 Citi Open Tennis Classic formerly Legg Mason. DDOT will complete the posting on Wednesday, July 24, 2013. ENPS will read **“EMERGENCY NO PARKING JULY 27, 2013 5:00 AM TO AUGUST 4, 2013 11:30 PM – SPECIAL PERMIT HOLDERS EXEMPTED – IF TOWED CALL 311.”** Residents in the affected areas will receive a letter about the event from Council member Muriel Bowser's office. These letters will be hand delivered.

Manchester LN From 14 th Street to the Park	17 th Street From Decatur Street to Colorado Ave.
17 th Street From Missouri Ave to Manchester LN	Blagden Terrace From Colorado Ave to 17 th Street
Manchester PL From Manchester LN to end of cul-de-sac	18 th Street From Colorado Ave to Blagden Ave
Colorado Ave From 14 th Street to end past Blagden Terrace	15 th Street From Decatur St. to Emerson St.
Ingraham St. From 14 th Street to Colorado Ave.	14 th Street -5300 block Both sides (from Decatur to Kennedy)

DDOT will also activate Variable Message Signs (VMS) on Wednesday, July 24, 2013 at 8:00 AM and run through Sunday August 4, 2013. The locations of the VMS boards are:

- 16th Street and N. Portal Street NW (facing South-bound traffic on 16th Street)
- 16th Street and Harvard Street NW (facing North-bound traffic on 16th street)
