**Re: Installation of Traffic Control Signal – Ward 4  
Notice 13-95-TOA**

Dear Commissioner Braxton:

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give written notice of our intent to modify traffic and/or parking requirements. This letter is being forwarded to each of the affected ANCs and the City Council Secretary for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

- Installation of a New Traffic Signal at the Intersection of Georgia Avenue and Quakenbos Street, NW. Removal of STOP Sign Control on Quakenbos Street, NW approaching Georgia Avenue

*Currently, Quakenbos Street, NW traffic is controlled by STOP signs at its intersection with Georgia Avenue. A new traffic signal is to be installed at the intersection of Georgia Avenue and Quakenbos Street, NW as a condition of development of adjacent property. DDOT has determined that the expected increases in vehicular and pedestrian activity as a result of this development justify the installation of traffic signal control. The proposed new traffic signal will provide for the safe and efficient movement of vehicular and pedestrian traffic at this intersection, and it can be coordinated with adjacent traffic signals on the Georgia Avenue, NW corridor to minimize disruptions to through traffic.*

*Therefore, in the interest of promoting the safe and efficient movement of vehicular and pedestrian traffic through and in the vicinity of this intersection, an independent determination has been made by the DDOT Transportation Services Administration to remove the existing STOP sign control on Quakenbos Street, NW at Georgia Avenue and to install and operate a traffic signal at the intersection of Georgia Avenue and Quakenbos Street, NW.*
