**Re: Installation of Traffic Control Signal – Ward 3  
Notice 13-98-TOA**

Dear Commissioner Roller:

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give written notice of our intent to modify traffic and/or parking requirements. This letter is being forwarded to each of the affected ANCs and the City Council Secretary for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

- Installation of a New Traffic Signal at the Intersection of Wisconsin Avenue and Idaho Avenue, NW. Removal of STOP Sign Control on Idaho Avenue, NW approaching Wisconsin Avenue.


*Currently, Idaho Avenue, NW traffic is controlled by a STOP sign at its intersection with Wisconsin Avenue. A new traffic signal is to be installed at the intersection of Wisconsin Avenue and Idaho Avenue, NW as a condition of the Cathedral Commons development adjacent to this intersection. DDOT has determined that expected increases in vehicular and pedestrian activity coupled with new traffic patterns resulting from the development justify the installation of traffic signal control. The proposed new traffic signal will provide for the safe and efficient movement of vehicular and pedestrian traffic at this intersection, and it can be coordinated with adjacent traffic signals on the Wisconsin Avenue, NW corridor to minimize disruptions to through traffic.*

*Therefore, in the interest of promoting the safe and efficient movement of vehicular and pedestrian traffic through and in the vicinity of this intersection, an independent determination has been made by the DDOT Transportation Services Administration to remove the existing STOP sign control on Idaho Avenue, NW at Wisconsin Avenue, and to install and operate a traffic signal at the intersection of Wisconsin Avenue and Idaho Avenue, NW.*
